# **SCOPE OF WORK**

Construction and installation of 74' flat pan patio cover over front entrance. Structure will contain 7" I beam for support and 6- 3x3 posts with footings into ground. 53' of structure, 28' on north side and 25' on south side of entrance, is 4' wide. Area directly over front entrance is 21' long by 6' wide.

#### **ELIGIBILITY**

To be eligible to bid, contractors must have been in business for a minimum of five years and must attend a mandatory pre-bid meeting on Wednesday, December 4, 2019 at 2:00 pm, at the facility, 1216 E 1300 S, Salt Lake City, Ut, 84105. During this meeting, contractors will discuss parameters of work, ask questions, and view project location.
